# Introduction

The obligation to keep electronic records of the supplies of goods and services not subject to tax, effected by a VAT group member to another member of the same VAT group was introduced by the Act Amending the Act on Personal Income Tax, Corporate Income tax and Certain Other Acts dated October 29<sup>th</sup>, 2021 (Journal of Laws of 2021, item 2105, as amended). The obligation enters into force on July 1<sup>st</sup>, 2023.<sup>1</sup>

Members of a VAT group are obliged to send their tax office, by means of electronic communication, tax records (JPK\_GV) covering monthly periods, by the 25<sup>th</sup> day of a month immediately following each subsequent month.

Elements of the records kept by members of a VAT group (JPK\_GV) are specified in the Ordinance of the Minister of Finance Concerning Records Kept by Members of a VAT Group dated March 30<sup>th</sup>, 2023 (Journal of Laws of 2023, item 727), hereinafter referred to as the "Ordinance", and in the model logical structure of JPK\_GV(1) developed on its basis.

More information on VAT groups, including obligations related to the keeping of tax records can be found in the tax explanations for VAT groups dated October 11<sup>th</sup>, 2022.<sup>2</sup>

# Formats of fields (data) of the JPK\_GV file

General characteristics of the fields' format:

- 1. The JPK\_GV is an XML-format file.
- 2. The fields of the XML file come into three categories:
  - obligatory fields to be filled in each time a filing is made; if the required data are not available, the word "BRAK" should be entered,
  - contingent fields to be filled in only in cases where there are certain data that need to be recorded mandatorily; if there are no such data, these fields should be left blank,
  - optional fields that is, fields that may but do not have to be filled in; if a taxable person chooses not to provide certain information (e.g. contact details such as a telephone number), these fields should be left blank.
- 3. The character fields are alphanumerical fields. Small and capital letters and digits are allowed. As a rule, the maximum number of signs is 256.
- 4. Polish diacritics are encoded with the use of UTF-8. Special characters such as "/", "-" or "+" may be used in character fields.
- 5. Numeric fields are data fields intended for numbers to be calculated. Values should be provided in the form of continuous sequences of digits (e.g. 123456); no separating marks (e.g. spaces) are allowed for thousands.

- 6. In the records, amounts should be rounded up to 2 decimal places, if any (e.g. 12345.56). The only admissible decimal separator is a dot (".").
- 7. All negative numbers should be preceded by the negative sign ("-").
- 8. Dates should be entered as YYYY-MM-DD.
- 9. Dates and time should be entered in one field only, i.e. the field intended for the date and time when the file is generated. The date and time format is YYYY-MM-DDTHH:MM:SS (e.g.: 2023-08-24T09:30:47Z, T standing for "Time"). For the Universal Time (UTC), the letter "Z" (ZULU) should be added at the end.
- 10. Tax identification numbers provided in the records should be sequences of consecutive digits or letters entered without spaces or other separators.






Diagram 2. The structure of the element Naglowek of JPK\_GV



**Podmiot1** of JPK\_GV is made of the following fields: **OsobaFizyczna** and **OsobaNiefizyczna**.

The following fields are intended for the identification data of natural persons: NIP, ImiePierwsze, Nazwisko, DataUrodzenia, Email and Telefon.

The following fields are intended for the identification data of entities other than natural persons: NIP, PelnaNazwa, Email and Telefon.



#### Diagram 3. The structure of the element Podmiot1 of JPK\_GV





# The records

General filing guidelines pertaining to the records of JPK\_GV

- 1. A taxable person wishing to make an amendment to the records should submit a new and complete XML-format file containing accurate data. Filings containing amended data only are not allowed.
- 2. A correction to an erroneous entry shall, as a rule, be made by way of providing the correct entry or reversing the erroneous one.
- 3. The size of letters does not matter.
- 4. Documentary evidence numbers should be recognized in the records in full and with original spelling. No identification data of any such documentary evidence may be omitted.
- 5. Amounts should be provided in PLN and rounded up to the nearest zloty in such a manner that fractional parts smaller than PLN 50/100 should be ignored and these greater than PLN 50/100 should be rounded up to the nearest zloty. Amounts expressed in a foreign currency should be translated into PLN according to the principles of translating amounts determining the tax base.
- 6. In cases where no transactions are effected in a period concerned by a VAT group member to another VAT group member, "zero records" should be filed, that is, 0.00 should be entered in the field SprzedazCtrl.




#### Diagram 5. The structure of the element Ewidencja of $\mathsf{JPK}\_\mathsf{GV}$

Diagram 6. The structure of the element Dokumenty of JPK\_GV



Diagram 8. The structure of the element SprzedazCrtl of JPK\_GV


